Debt Payment Suspension (PKPU) & Bankruptcy

- Proceedings for court approval of composition (homologation);
- Assistance in the liquidation of bankruptcy estates and the resolution of disputes arising from bankruptcy proceedings.

Each matter is handled through a strategic litigation approach that carefully considers legal aspects, business interests, and mitigation of legal and financial risks, ensuring optimal protection of the client's legal position.



Special Criminal Law – Corruption Offenses

Legal assistance is rendered comprehensively from the investigation and inquiry stages, through prosecution and trial proceedings, with representation before the Indonesian National Police, the Public Prosecutor's Office, the Corruption Eradication Commission (KPK), and the Corruption Court (*Pengadilan Tindak Pidana Korupsi*).

In particular, with respect to the representation of defendants before the Corruption Court, our litigation services include, among others:

- Preparation and submission of procedural objections (exceptions) against indictments;
- Preparation and presentation of defense pleadings (pledoi), as well as responses to prosecutors' replies and rejoinders;
- Examination, analysis, and assessment of documentary evidence, witness testimony, and expert opinions;
- Legal representation throughout all stages of court hearings;
- Preparation and submission of final conclusions;
- Legal assistance in pursuing and handling available legal remedies in accordance with prevailing laws and regulations.

In addition, Our Firm also provides legal assistance to:

- Reporting parties, in connection with reporting procedures and clarification processes;
- Reported parties and suspects, throughout all stages of criminal proceedings;
- Witnesses, during investigation, inquiry, and trial examinations.

All special criminal matters are handled with strict adherence to the principles of prudence, confidentiality, and due process of law, supported by a comprehensive understanding of the legal, reputational, and risk implications inherent in each case.
